# On Match Days

## **BEFORE THE GAME**

Please book in at Football Reception at least 30 minutes before your scheduled kick off time and register your attendance.

Exchange your Player Registration ID cards with the opposition Team Manager for checking at least 15 minutes before your scheduled kick off time, then return them immediately.

**PLEASE REPORT ANY QUERIES OR CONCERNS ABOUT PLAYER REGISTRATION ID CARDS TO YOUR SITE MANAGER BEFORE THE GAME STARTS BECAUSE COMPLAINTS OF THIS NATURE WILL NOT BE INVESTIGATED LATER.**

Prior to the game, participating Teams are required to line up and conduct the 'Respect' handshake.

## **DURING THE GAME**

Record your starting line-up and goal scorers in readiness for loading on to "Full Time" at <https://fulltime-admin.thefa.com/>

Make a note of the players when they enter the field of play for the first time.

## **AFTER THE GAME**

After the game, participating Teams are expected to conduct the 'Respect' handshake.

Record the final score clearly and accurately, you will receive a text to record your scores using the automated "Full Time System" Enter your score and send. If you manage more than one team you MUST use the short code along with the score i.e 1-1 SN03.

Complete the 'Fair Play Award' and 'Referees Marks' on the Full Time System which will unlock the Player Statistics tab ( a full guide to completing the FA Marks and Player Statistics can be found on our website by going to [www.kickstartfootball.co.uk](http://www.kickstartfootball.co.uk). Please ensure that the text is replied to within 3 hours of the final whistle and Full-Time completed by 9pm Monday evening. Failure to do so will result in a charge and fine for failing to follow a management instruction. The fines will be £5 for the first offence; £10 for each subsequent offences.

The match fees are £26.00 per Team for 5 v 5, £35.00 per Team for 7 v 7 and £45.00 per Team for 9 v 9.

In accordance with Rule 20 (F) a Mini Soccer Team must not have a match day squad greater than double the size of its team; therefore the maximum squad permitted is 10 players for 5 v 5 and 14 players for 7 v 7.

In Youth Football - 9 v 9 a Team may use up to 7 from 7 substitute Players, therefore the maximum squad permitted on match days for 9 v 9 is 16 players.

All club officials – Chairman, Secretary, Treasurer and Welfare Officer - must be registered with the league with a current email address and mobile contact number. This must be kept up to date throughout the season.

PLAYERS WISHING TO PLAY UP A YEAR – All age groups – players will be permitted to play in a team a year above apart from a player that attains their sixth birthday during the season. They are not permitted to play up at U8.

## Referee's Mark

### **Please award marks out of 100 for your Referee**

If you have any complaints about the performance of a Referee or any incidents occurring involving your Referee or you score your Referee 60 points or below, your Club Secretary must send a report to the League Secretary, copied to the Referees Secretary, within 2 days of the Competition Match (excluding Sunday), in order for the matter to be investigated. You can also add notes into the Box provided to log the incident with Full Time however the report must still be sent to the league secretary.

## **A Guide to marking Referees**

The mark awarded to a Referee by a Club must be based on the overall performance. It is **most** important that the mark is awarded fairly and not based upon isolated incidents or previous matches. The Referees mark should be determined by the table below, which should act as a guide. Please see notes below for help in making your decision on the Referees mark. Please remember any Club marking a Referee with a mark of 60 or below must provide a letter or email with the reasons as to why by Tuesday 9pm after the game. The purpose of this is to assist the League in improving the Referees performance and will be acted upon. So please ensure the comments are as accurate as possible, and not just that the Referee was poor.

### **A few points to help you decide on the Referees mark**

- How well did the Referee control the game?
- Were all laws applied correctly?
- Were all incidents dealt with correctly?
- Was the Referee well positioned to see all incidents?
- Did the Referee stay alert and concentrate throughout the game?
- How well did the Referee communicate with the players during the game?
- Was the Referee confident when making decisions?
- Did the Referee look the part? Correct full Referee kit (please note that tracksuit bottoms and jumpers/skins under the Referees kit are permitted by the League in bleak weather).
- Was the Referee mobile in movement during the game or were they static?
- Did the Referee use a good and clear whistle tone during the game or did the players struggle to hear the Referee?

### **Final thoughts before marking the Referee**

- Don't mark the Referee down unfairly because your Team was unlucky and lost the game.
- Judge the performance over the whole game and not on the one decision you didn't get.

# Registrations, Transfers & De-Registrations

## **HOW TO REGISTER A NEW AND EXISTING PLAYER**

All new and existing players must be registered on the FA Club Portal as voted on and agreed by the membership. To register players you need to visit <https://clubs.thefa.com/> and log in with your email and password. If you have forgotten your FAN number or password visit [www.thefa.com/account/requestpasswordreset](http://www.thefa.com/account/requestpasswordreset).

See the document guide 'Registering Players system on the KickStart website under 'Documents & Forms' then under the 'Documents' heading to assist you with the process.

Within the process it is a requirement of the League that all Club Secretaries and/or any person designated as a Player Registration Officer to the FA Club Portal, will need to verify that they have seen at least one document attesting to a players' date of birth which must be in the form of either a birth certificate, passport or medical card. It is also a requirement of the League that a current passport size photograph must be attached to the FA Club Portal all players in every age group this Season. Please see 'Player Photo Guidance' on the KickStart website for a full guide to player photo requirements.

Please note that a minimum of 5 players for 5 v 5, 7 players for 7 v 7 and 9 players for 9 v 9 must be registered on the FA Club Portal on or before 15<sup>th</sup> August 2025. Player ID cards will continue to be produced for the 25/26 season.

The deadline for registering a player onto the FA Club Portal on a week to week basis once the Season has commenced is by 9.00 pm on the Thursday preceding the playing Sunday. This is necessary to allow enough time for the registration to be approved by the League Registrar and the Player ID card to be printed. PAYMENT IN THE SUM OF £3.00 PER PLAYER WILL BE PAYABLE ON COLLECTION OF PLAYER ID CARDS. Player ID cards will be available for collection from Football Reception at the start of the Season and on a weekly basis as and when a new player is registered. Please ensure that all player cards are collected before your game.

## **HOW TO TRANSFER A PLAYER**

'Transferring a player' Guidelines using the FA Club Portal can be found on the KickStart website at [www.kickstartfootball.co.uk](http://www.kickstartfootball.co.uk) under 'Documents & Forms' Then under the 'Documents' heading. This should provide all the information you require to assist you with the process of transferring players on the FA Club Portal. The last day to register a new player or transfer a player is 16th March 2026.

## **WHEN BOTH CLUBS AGREE TO THE TRANSFER**

The 7 days written notice of approach may be waived if both Clubs are in agreement with the transfer. If a player that the Club wishes to add is already registered with another Club in the current season and that Club has teams that play on the same day, a 'Notice of Approach' must be submitted. An additional pop-up will allow the Club to confirm that the other Club has waived notice. This option should only be selected if direct communication has been made with the current parent club and they have allowed an approach to be made. In all other circumstances, the approaching club must abide by the FA rule and serve a 7 day notice period to the parent club secretary and copied in to the league secretary.

Once a notice of approach has been sent, the player will be marked as 'Transfer Requested'. Any notice of approach submissions will be stored in the Transfers section whilst awaiting the end of 7 day period. If a player has yet to be registered in the current season, or if they are registered to a Club that doesn't have any teams that play on the same day as the approaching Club, no notice of approach will be required as per standard practice. Once the 7 day period for a notice of approach has been served, the player record in the Transfers section will include a button allowing the "Start Transfer". This will submit the request to the current parent club and send them a notification that the transfer needs to be processed. The current parent club will have the option to 'Approve Transfer' or 'Reject'. Approving the transfer will remove the request from both clubs and place the player into the Players section of the new club. Once players have been added to the Club, it is then possible to request player consent for registration and submit these registrations through to the league for approval. If done before the deadline of 9.00pm on the Thursday, the player should have their playing card available at KickStart Football Reception on the Sunday and be allowed to play. PAYMENT IN THE SUM OF £3.00 PER PLAYER WILL BE PAYABLE ON COLLECTION OF PLAYER ID CARDS.

## **WHEN A CLUB HOLDING THE REGISTRATION DOES NOT AGREE TO THE TRANSFER**

Clubs wishing to transfer a player from another Club must give them 7 days' notice of intent of approach as per FA Rule C2(a). This must be completed by Club Secretaries on the WGS Player Registration System. Clubs may approach the player from the 8th day of the date of the submission of intent. If the player wishes to transfer, once consent has been obtained the player can be assigned to the team and registration submitted to the league.

Please note that there are no existing reasons which may be brought into the process which would prohibit a youth football player from transferring.

## HOW TO DE-REGISTER A PLAYER

To de-register a player, you must return the players registration ID card to your Football Reception or to the League Secretary/Registrar direct, then using "Club Portal team administrators must go in to the players record and select "CANCEL REGISTRATION" thus the player(s) will be removed from your team. There is no charge for this process.

Following the above, the league will cancel the registration of the player(s) to enable the Secretary/Player Registration Officer for the club to detach the player where required using the Club Portal. Details on the above can be found on the KickStart website at [www.kickstartfootball.co.uk](http://www.kickstartfootball.co.uk) under 'Documents & Forms' Then under the 'Documents' heading.

In age groups U7s - U10s for offences that would normally result in a dropped ball or indirect free kick within the penalty area under normal rules, the restart of play will be from the penalty area line, parallel with the goal line, at the nearest point to the offence.

# Respect



**Respect is the collective responsibility of everyone involved in football to create a fair, safe and enjoyable environment in which the game can take place.**

We never want the passion or emotion removing from the game, but if we all work together we can channel it in the right direction and provide an action packed environment full of positivity which everyone can enjoy and benefit from.

## **On and off the field; you will: -**

- Show respect to others involved in the game including match officials, opposition players, coaches, managers, officials and spectators
- Understand that the actions of your club members (supporters) is your responsibility. Ensure they stay behind the respect line and never go behind either goal area
- Be sporting - applaud good play whichever team produces it
- Adhere to the laws and spirit of the game
- Promote Fair Play and high standards of behaviour
- Always respect the match official's decision
- Never enter the field of play without the referee's permission
- Never engage in public criticism of the match officials
- Never engage in, or tolerate, offensive, insulting or abusive language or behaviour
- Ensure your club members (spectators) do not try and give the players instructions - that is your job and players will only get confused
- Shake hands with the opposition at the end of the game, regardless of the score

## **When working with players; you will: -**

- Place the well-being, safety and enjoyment of each player above everything, including winning
- Explain exactly what you expect of players and what they can expect from you
- Make sure your language is appropriate for the age you are coaching
- Let the players play the game. Don't play it for them
- Give each player a reasonable amount of playing time
- Ensure all parents/carers of all players under the age of 18 understand these expectations
- Never engage in or tolerate any form of bullying
- Develop mutual trust and respect with every player to build their self-esteem
- Encourage each player to accept responsibility for their own behaviour and performance
- Ensure all instructions are appropriate for the players' ability level, age and maturity
- Co-operate fully with others in football (e.g. league officials, welfare officers) in each player's best interests



# **Bad Weather Cancellations**

Occasionally it may be necessary to cancel games due to pitch conditions or bad weather. If this is the case please follow the procedure below: -

**If the weather looks bleak or there has been heavy rain all week or there is frost or snow on the ground**

1. Check to see if you have received a text message or an email from your League Headquarters, Site Manager or Administrator.
2. Visit our Discord, Website [www.kickstartfootball.co.uk](http://www.kickstartfootball.co.uk), Facebook or see Full Time
3. If you have not received a cancellation message and there is no posting on the 'Home' page of our Website, Facebook or Full Time but you are still in doubt, please ring your Site Manager or Site Administrator (as listed below); but not until 9.00 am on the playing Sunday morning for the 10.00 am kick offs, 9.30 am for 11.00/11.15 am kick offs and 10.30 am for all later games, which gives you at least an hour and a half to contact your parents.

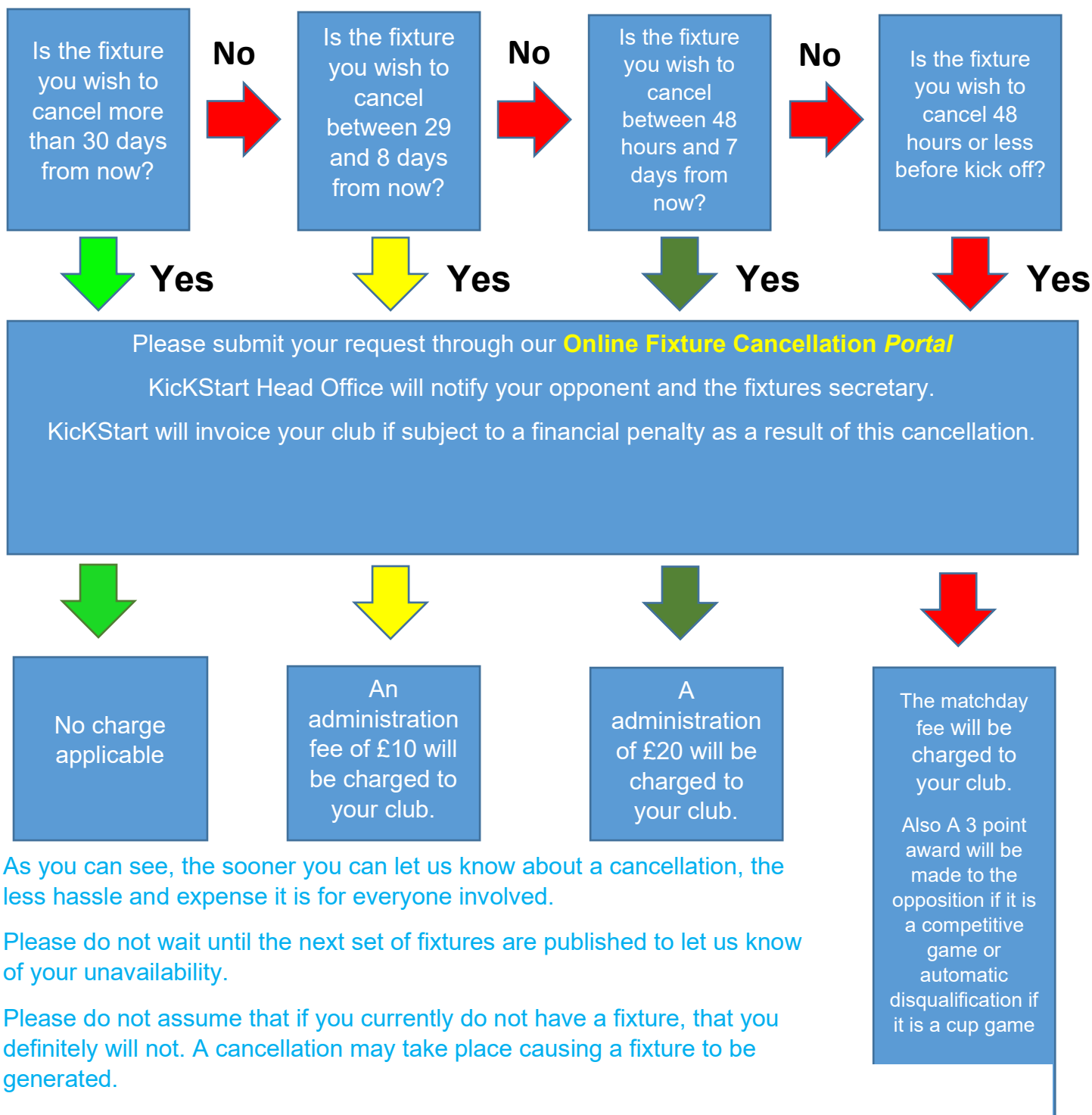


**The League will give you as much notice as possible, where possible, of any cancellations caused by bad weather, but it is ultimately the responsibility of Team Managers' to find out if matches are cancelled and advise Players' and Parents/Carers accordingly.**

**Please advise your Parents/Carers not to ring the League personally - we would appreciate one phone call per team only please.**

# Cancelling/Postponing a Match

The League understands that sometimes this can be unavoidable, but if the matter arises please follow the procedure below: -



Check your fixtures regularly, DO NOT print out a list of fixtures to hand out to your Players' Parents/Carers. Fixtures are subject to change up to Friday evening, although this is rare. If a fixture has changed with less than seven days until the fixture, you will receive a text notification from the Fixtures Secretary.

# Venue Rules & Information

ALCOHOL, SMOKING or VAPING is NOT allowed on any touchline in the interests of Health & Safety and Safeguarding Children.

FUND-RAISING on match days by the **HOME** team (as per your 'Team Sheet') is permitted on all KickStart venues, providing it involves spectators surrounding your pitch; supporting your game only.

# Queries or Complaints

Remember you are not alone playing in the KickStart League. You have a Site Manager and an Administrator with you on site who are there to provide help or support at any time. If the behaviour of anyone causes you concern, or you think this behaviour or any incident(s) may become the subject of a complaint later, please ask for assistance to try and resolve the matter there and then. If this cannot be resolved, see Rule 7 'Protests, Claims, Complaints, Appeals' in the Standard Code of Rules and follow the complaints procedure.

## **Complaints regarding Player Registrations**

If there appears to be an issue after checking the player registration ID cards and/or team sheet before the game, this must be dealt with before the game starts. Your Site Manager will be able to support you with this. Please note, any complaints made after the game has started will not be investigated.

Any other issues, queries or complaints concerning player registrations must be referred to the League Secretary/Registrar.

## **Complaints regarding Referees**

If you have any complaints about the performance of a Referee or any incidents occurring involving your Referee, please **DO NOT** address this directly with him/her on the match day.

Ensure you score your Referee 60 points or below on the Full Time system and advise your Club Secretary to send a report to the League Secretary, copied to the Referees Secretary. This report must be sent in writing (by letter or email) within 2 days of the match (excluding Sundays), in order for the matter to be investigated.

## **Complaints regarding Team Managers, Coaches or Spectators**

If you have cause to complain about the behaviour of Team Managers, Coaches or Spectators, ensure you score the relevant members accordingly on the Full Time system and advise your Club Secretary to send a report to the League Secretary. This report must be sent in writing (by letter or email) within 2 days of the match (excluding Sundays), in order for the matter to be investigated. Please also report to your site manager at the time of the incident.

## **Complaints regarding 'Respect'**

If you have any complaints regarding non-adherence to the 'Respect' programme, a report must be submitted in writing detailing which parts of the 'Respect' programme you consider have been breached.

This report must be sent from your Club Secretary in writing (by letter or email) within 2 days of the match (excluding Sundays), in order for the matter to be investigated.

**Please note that if the complaint involves a child welfare issue, this must be reported to your Club's Child Welfare Officer who will liaise with the League's Welfare Officer.**

## 2025-2026 Kickstart Youth Football League Rules

Based on the Standard Code of Rules for Mini Soccer and Youth Football competitions

1. DEFINITIONS	
1.A	<p>In these Rules:</p> <p><b>“Affiliated Association”</b> means an Association accorded the status of an Affiliated Association under the rules of The FA.</p> <p><b>“AGM”</b> shall mean the annual general meeting held in accordance with the constitution of the Competition.</p> <p><b>“Club”</b> means a club for the time being in membership of the Competition.</p> <p><b>“Club Portal”</b> means the system used by Clubs to affiliate teams as determined by The FA from time to time.</p> <p><b>“Competition”</b> means the Kickstart Youth Football League.</p> <p><b>“Competition Match”</b> means any match played or to be played under the jurisdiction of the Competition.</p> <p><b>“Contract Player”</b> means any Player (other than a Player on a Scholarship) who is eligible to play under a written contract of employment with a Club.</p> <p><b>“Deposit”</b> means a sum of money deposited with the Competition as part of the requirements of membership of the Competition.</p> <p><b>“Fees Tariff”</b> means a list of fees approved by the Clubs at a general meeting to be levied by the Management Committee for any matters for which fees are payable under the Rules, as set out at Schedule A.</p> <p><b>“Fines Tariff”</b> means a list of fines approved by the Clubs at a general meeting to be levied by the Management Committee for any breach of the Rules, as set out at Schedule A.</p> <p><b>“Ground”</b> means the ground on which the Club’s Team(s) plays its Competition Matches.</p> <p><b>“Management Committee”</b> means in the case of a Competition which is an unincorporated association, the management committee elected to manage the running of the Competition and where the Competition is incorporated it means the Board of Directors appointed in accordance with the articles of association of that company.</p> <p><b>“Match Officials”</b> means the referee, the assistant referees and any fourth official appointed to a Competition Match.</p> <p><b>“Mini Soccer”</b> means those participating at ages under 7s to under 10s</p> <p><b>“Non Contract Player”</b> means any Player (other than a Player on a Scholarship) who is eligible to play for a Club but has not entered into a written contract of employment.</p> <p><b>“Officer”</b> means an individual who is appointed or elected to a position in a Club or Competition which requires that individual to make day to day decisions.</p> <p><b>“Participant”</b> shall have the same meaning as set out in the rules of The FA from time to time.</p> <p><b>“Player”</b> means any Contract Player, Non Contract Player or other player who plays or who is eligible to play for a Club.</p> <p><b>“Player Registration System”</b> means The FA system to register players as determined by The FA from time to time.</p> <p><b>“Playing Season”</b> means the period between the date on which the first competitive fixture in the Competition is played each year until the date on which the last competitive fixture in the Competition is played.</p>

	<p><b>“Rules”</b> means these rules under which the Competition is administered.</p> <p><b>“Sanctioning Authority”</b> means [The FA][the Nottinghamshire County Football Association Limited].</p> <p><b>“Scholarship”</b> means a Scholarship as defined in The FA rules.</p> <p><b>“Season”</b> means the period of time between an AGM and the subsequent AGM.</p> <p><b>“Secretary”</b> means such person or persons appointed or elected to carry out the administration of the Competition.</p> <p><b>“SGM”</b> means a special general meeting held in accordance with the constitution of the Competition.</p> <p><b>“Team”</b> means a team affiliated to a Club, including where a Club provides more than one team in the Competition in accordance with the Rules.</p> <p><b>“The FA”</b> means The Football Association Limited.</p> <p><b>“Virtual Meetings”</b> means meetings held electronically.</p> <p><b>“written” or “in writing”</b> means the representation or reproduction of words or symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise.</p> <p><b>“Youth Football”</b> means those participating at ages under 11s to under 18s.</p>
1.B	Unless stated otherwise, terms referring to natural persons are applicable to both genders. Any term in the singular applies to the plural and vice-versa.
<b>GOVERNANCE RULES</b>	
<b>2. COMPETITION NAME AND CONSTITUTION</b>	
2.A	The Competition will be known as Kickstart Youth Football League (or such other name as the Competition may adopt). The Clubs participating in the Competition must be members of the Competition. A Club which ceases to exist or which ceases to be entitled to play in the Competition for any reason whatsoever shall thereupon automatically cease to be a member of the Competition.
2.B	This Competition shall consist of not more than 80 Clubs approved by the Sanctioning Authority
2.C	The geographical area covered by the Competition membership shall be 25 mile radius of NG18 2QH.
2.D	The administration of the Competition under these Rules will be carried out by the Competition acting (save where otherwise specifically mentioned herein) through the Management Committee in accordance with the rules, regulations and policies of The FA.
2.E	All Clubs shall adhere to the Rules. Every Club shall be deemed, as a member of the Competition to have accepted the Rules and to have agreed to abide by the decisions of the Management Committee in relation thereto, subject to the provisions of Rule 7.
2.F	The Rules are taken from the Standard Code of Rules for Youth Competitions (the “Standard Code”) determined by The FA from time to time. In the event of any omissions from the Standard Code then the requirements of the Standard Code shall be deemed to apply to the Competition
2.G	<p>1. All Clubs must be affiliated to an Affiliated Association.</p> <p>2. This Competition shall apply annually for sanction to the Sanctioning Authority and the constituent Teams of Clubs may be grouped in divisions, each not exceeding 20 in number.</p>
2.H	<p>Inclusivity and Non-discrimination</p> <ol style="list-style-type: none"> <li>1. The Competition and each Club must be committed to promoting inclusivity and to eliminating all forms of discrimination and should abide and adhere to The FA Equality Policy and any legislative requirements (to include those contained in the Equality Act 2010).</li> <li>2. This Competition and each Club must make every effort to promote equality by treating people fairly and with respect, by recognising that inequalities may exist, by taking steps to address them and by providing access and opportunities for all members of the community, irrespective of age, gender, gender reassignment, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability or otherwise.</li> <li>3. Any alleged breach of the Equality Act 2010 legislation must be referred to the appropriate Sanctioning Authority for investigation.</li> </ol>
2.I	Clubs must comply with the provisions of any initiatives of The FA which are adopted by the Competition including, but not limited to, England Football Accredited and RESPECT programmes. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
2.J	All Participants shall abide by The Football Association Regulations for Safeguarding Children as determined by The FA from time to time.
2.K	Clubs shall not enter any of their Teams playing at a particular age group in the Competition in any other competition (with the exception of FA and County FA Competitions) except with the written consent of the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff. A Club must immediately inform the Competition of the details of any fixture(s) in any other competition in which the Club has entered, for which written consent of the Management Committee has been obtained
2.L	At the AGM or a SGM called for the purpose, a majority of the delegates present shall have power to decide or adjust the constitution of the divisions at their discretion. When necessary this Rule shall take precedence over Rule 22.

3. CLUB NAME	
3	Any Club wishing to change its name must obtain permission from the Sanctioning Authority and from the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
4. ENTRY FEE, SUBSCRIPTION, DEPOSIT	
4.A	Applications by Clubs for admission to the Competition or the entry of an additional Team(s) from the same Club must be made in writing to the Secretary by 31 <sup>st</sup> July and must be accompanied by an entry fee per Team as set out in the Fees Tariff, which shall be returned in the event of non-election.  At the discretion of the voting members present applications, of which due notice has been given, may be received at the AGM or a SGM or on a date agreed by the Management Committee.
4.B	The annual subscription shall be payable in accordance with the Fees Tariff per Club/Team (where a Club has more than one Team in membership of the Competition) and shall be payable on or before 31 <sup>st</sup> August in each year.
4.C	A Deposit of £50 shall be payable in accordance with the Fees Tariff per Club/Team (where a Club provides more than one Team in membership of the Competition) and shall be payable on or before 31 <sup>st</sup> August in each year. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
4.D	A Club shall not participate in this Competition until the entry fee, annual subscription and Deposit (if required) have been paid.
4.E	Clubs must ensure that all its teams participating in the Competition are recorded as affiliated on the Club Portal for the forthcoming Playing Season by the following date 1 <sup>st</sup> September Clubs must advise the Competition Secretary in a manner prescribed by the Sanctioning Authority, or on the prescribed form, of details of its headquarters, its Officers and any other information required by the Competition. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
4.F	An all-female team can apply to the Competition to play an age group down in a mixed gender competition, subject to rule 8A(iii)&(iv) and provided the team has obtained approval from its Sanctioning Authority.
5. MANAGEMENT, NOMINATION, ELECTION	
5.A	The Management Committee shall comprise the Officers of the Competition and a minimum of one member (but no more than 4 members), who shall all be elected at the AGM.
5.B	Retiring Officers shall be eligible to become candidates for re-election without nomination provided that the Officer notifies the Secretary in writing not later than 1 <sup>st</sup> April in each year.  All other candidates for election as Officers of the Competition or members of the Management Committee shall be nominated to the Secretary in writing, signed by the secretaries of two Clubs, not later than 31 <sup>st</sup> May in each year. Names of the candidates for election shall be circulated with the notice of the AGM. In the event of there being no nomination in accordance with the foregoing for any office, nominations may be received at the AGM.
5.C	The Management Committee shall meet as and when required, save that no more than three calendar months shall pass between each meeting.  On receiving a requisition signed by two-thirds (2/3) of the members of the Management Committee the Secretary shall convene a meeting of the Management Committee.
5.D	Except where otherwise mentioned all communications shall be addressed to the Secretary who shall conduct the correspondence of the Competition and keep a record of its proceedings.
5.E	All communications received from Clubs must be conducted through their Officers and sent to the Secretary.  Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
6. POWERS OF MANAGEMENT	
6.A	The Management Committee may appoint sub-committees and delegate such of their powers as they deem necessary. The decisions of all sub-committees shall be reported to the Management Committee for ratification. The Management Committee shall have power to deal only with matters within the Competition and not for any matters of misconduct that are under the jurisdiction of The FA or Affiliated Association.
6.B	Subject to the permission of the Sanctioning Authority having been obtained the Management Committee may order a match or matches to be played each Season, the proceeds to be devoted to the funds of the Competition and, if necessary, may call upon each Club (including any club which may have withdrawn during the Season) to contribute equally such sums as may be necessary to meet any deficiency at the end of the Season.
6.C	Each member of the Management Committee shall have the right to attend and vote at all Management Committee meetings and have one vote thereat, but no member shall be allowed to vote on any matters directly appertaining to such member or to the Club so represented or where there may be a conflict of interest. (This shall also apply to the procedure of any sub-committee).

	<p>In the event of the voting being equal on any matter, the Chairman of the Management Committee shall have a second or casting vote.</p>
6.D	<p>The Management Committee shall have powers to apply, act upon and enforce these Rules and shall also have jurisdiction over all matters affecting the Competition. Any action by the Competition must be taken within 28 days of the Competition being notified.</p> <p>With the exception of Rules 6(I), 8(H) and 9, for all alleged breaches of a Rule the Management Committee shall issue a formal written charge to the Club concerned. The Club charged shall be given 7 days from the date of notification of the charge to reply. In such reply a Club may:-</p> <ul style="list-style-type: none"> <li>(i) Accept the charge and submit in writing a case of mitigation for consideration by the Management Committee on the papers; or</li> <li>(ii) Accept the charge and notify that it wishes to put its case of mitigation at a hearing before the Management Committee; or</li> <li>(iii) Deny the charge and submit in writing supporting evidence for consideration by the Management Committee on the papers; or</li> <li>(iv) Deny the charge and notify that it wishes to put its case at a hearing before the Management Committee.</li> </ul> <p>Where the Club charged fails to respond within 7 days, the Management Committee shall determine the charge in such manner and upon such evidence as it considers appropriate.</p> <p>Where required, hearings shall take place as soon as reasonably practicable following receipt of the reply of the Club as more fully set out above.</p> <p>Having considered the reply of the Club (whether in writing or at a hearing), the Management Committee shall make its decision and, in the event that the charge is accepted or proven, decide on the appropriate penalty (with reference to the Fines Tariff where applicable).</p> <p>The maximum fine permitted for any breach of a Rule is £100 and, when setting any fine, the Management Committee must ensure that the penalty is proportional to the offence, taking into account any mitigating circumstances.</p> <p>No Participant under the age of 18 can be fined.</p> <p>All breaches of the Laws of the Game or the Rules and Regulations of The FA shall be dealt with in accordance with FA Rules by the appropriate Association.</p>
6.E	<p>All decisions of the Management Committee shall be binding subject to the right of appeal in accordance with Rule 7.</p> <p>Decisions of the Management Committee must be notified in writing to those concerned within 7 days.</p>
6.F	<p>50% of its members shall constitute a quorum for the transaction of business by the Management Committee or any sub-committee thereof.</p>
6.G	<p>The Management Committee, as it may deem necessary, shall have power to fill, in an acting capacity, any vacancies that may occur amongst their number.</p>
6.H	<p>A Club must comply with an order or instruction of the Management Committee, and must attend to the business and/or the correspondence of the Competition to the satisfaction of the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>
6.I	<p>Subject to a Club's right of appeal in accordance with Rule 7 below, all fines and charges must be paid within 14 days of the date of notification of the decision.</p>

	Any Club failing to do so will be fined in accordance with the Fines Tariff. Further failure to pay the fine including the additional fine within a further 14 days will result in fixtures being withdrawn until such time as the outstanding fines are paid.
6.J	A member of the Management Committee appointed by the Competition to attend a meeting or Competition Match may have any reasonable expenses incurred refunded by the Competition.
6.K	The Management Committee shall have the power to fill any vacancy that may occur in the membership of the Competition between the AGM or SGM called to decide the constitution and the commencement of the Playing Season.
6.L	The business of the Competition as determined by the Management Committee may be transacted by electronic mail or facsimile
<b>7. PROTESTS, CLAIMS, COMPLAINTS, APPEALS</b>	
7.A	<p>1. All questions of eligibility, qualification of Players or interpretations of the Rules shall be referred to the Management Committee or a sub-committee duly appointed by the Management Committee.</p> <p>2. Objections relevant to the dimensions of the pitch, goals, flag posts or other facilities of the venue will not be entertained by the Management Committee unless a protest is lodged with the referee before the commencement of the Competition Match.</p>
7.B	Except in cases where the Management Committee decide that there are special circumstances, protests and complaints (which must contain full particulars of the grounds upon which they are founded) must be lodged with the Secretary within 2 days (excluding Sundays) of the Competition Match or occurrence to which they refer. A protest or complaint shall not be withdrawn except by permission of the Management Committee. A member of the Management Committee who is a member of any Club involved shall not be present (except as a witness or representative of their Club) when such protest or complaint is being determined.
7.C	No protest of whatever kind shall be considered by the Management Committee unless the complaining Club shall have deposited with the Secretary a sum in accordance with the Fees Tariff. This may be forfeited in whole or in part in the event of the complaining or protesting Club losing its case. The Competition shall have power to order the defaulting Club or the Club making a losing or frivolous protest or complaint to pay the expenses of the inquiry or to order that the costs to be shared by the parties.
7.D	<p>All parties to a protest or complaint must receive a copy of the submission and must be afforded an opportunity to make a statement at least 7 days prior to the protest or complaint being heard.</p> <ol style="list-style-type: none"> <li>1. All parties must have received a minimum of 7 days' notice of the hearing should they be instructed to attend.</li> <li>2. Should a Club elect to state its case in person then it should indicate such when forwarding the written response.</li> </ol>
7.E	The Management Committee shall also have power to compel any party to the protest to pay such expenses as the Management Committee shall direct.
7.F	<p>An intention to appeal against a decision of the Management Committee must be lodged with the Sanctioning Authority, with a copy sent to the Secretary, within 7 days of the Management Committee providing written notification of its decision.</p> <p>A notice of appeal against a decision of the Management Committee must be lodged with the Sanctioning Authority, with a copy sent to the Secretary, within 14 days of the Management Committee providing written notification of its decision, accompanied by the relevant fee (as set out in the Fees Tariff) which may be forfeited in the event of the appeal not being upheld. The procedure for the appeal shall be determined by the Sanctioning Authority.</p>
7.G	No appeal can be lodged against a decision taken at an AGM or SGM unless this is on the ground of unconstitutional conduct.
<b>8. ANNUAL GENERAL MEETING</b>	
8.A	<p>The AGM shall be held not later than 31<sup>st</sup> July in each year. At this meeting the following business shall be transacted provided that at least 50% of members are present and entitled to vote:-</p> <ol style="list-style-type: none"> <li>1. To receive and confirm the minutes of the preceding AGM.</li> <li>2. To receive and adopt the annual report, balance sheet and statement of accounts.</li> <li>3. Election of Clubs to fill vacancies.</li> <li>4. Constitution of the Competition for the ensuing Season.</li> <li>5. Election of Officers of the Competition and the Management Committee members.</li> <li>6. Appointment of auditors.</li> <li>7. Alteration of Rules, if any (see Rule 14).</li> <li>8. Fix the date for the commencement of the Playing Season and kick off times applicable to the Competition.</li> <li>9. Fix the date for the end of the Playing Season.</li> <li>10. Other business of which due notice shall have been given and accepted as being relevant to an AGM.</li> </ol>
8.B	A copy of the duly <i>audited/verified</i> balance sheet, statement of accounts and agenda shall be forwarded to each Club at least 14 days prior to the meeting together with any proposed Rule changes.
8.C	A signed copy of the duly <i>audited/verified</i> balance sheet and statement of accounts shall be sent to the Sanctioning Authority within 14 days of its adoption by the AGM.
8.D	Each Club shall be empowered to send two delegates to an AGM. Each Club shall be entitled to one vote only. 14 days' notice shall be given of any AGM.



8.E	Clubs who have withdrawn their membership of the Competition during the Playing Season being concluded or who are not continuing membership shall be entitled to attend but shall vote only on matters relating to the Season being concluded. This provision will not apply to Clubs expelled in accordance with Rule 12.
8.F	All voting shall be conducted by a show of hands, or count of email or virtual responses (for Virtual Meetings), unless a ballot be demanded by at least 50% of the delegates qualified to vote or the Chair so decides.
8.G	No individual shall be entitled to vote on behalf of more than one Club.
8.H	<ol style="list-style-type: none"> <li>Any continuing Club must be represented at the AGM. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</li> <li>Any club that has submitted a valid application to join the Competition for the forthcoming season must have the opportunity to be put forward for membership and to have a vote taken on their membership application.</li> </ol>
8.I	Officers of the Competition and Management Committee members shall be entitled to attend and vote at an AGM, but cannot also cast a vote on behalf of a club (See Rule 8.G).
8.J	Where a Competition is an incorporated entity, the Officers of the Competition shall ensure that the Articles of Association of the Competition are consistent with the requirements of these Rules.
<b>9. SPECIAL GENERAL MEETINGS</b>	
9.A	Upon receiving a requisition signed by two-thirds (2/3) of the Clubs in membership the Secretary shall call a SGM.
9.B	The Management Committee may call a SGM at any time.
9.C	At least seven (7) days' notice shall be given of a meeting under this Rule, together with an agenda of the business to be transacted at such meeting.
9.D	Each Club shall be empowered to send two delegates to all SGMs. Each Club shall be entitled to one vote only.
9.E	Any Club failing to be represented at a SGM shall be fined in accordance with the Fines Tariff.
9.F	Officers of the Competition and Management Committee members shall be entitled to attend and vote at all SGMs. but cannot also cast a vote on behalf of a club (see Rule 9.D).
<b>10. AGREEMENT TO BE SIGNED</b>	
10	<p>Each Club shall complete and sign the following agreement which shall be deposited with the Competition together with the application for membership for the coming Season, or upon indicating that the Club intends to compete.</p> <p>"We, (A), (name) [ ] of (address) [ ] (Chairman)/Director and (B) (name) [ ] of (address) [ ] (Secretary/Director) of [ ] Football Club (Limited) have been provided with a copy of the Rules and Regulations of the [ ] Competition and do hereby agree for and on behalf of the said Club, if elected or accepted into membership, to conform to those Rules and Regulations and to accept, abide by and implement the decisions of the Management Committee of the Competition, subject to the right of appeal in accordance with Rule 7."</p> <p>The agreement shall be signed by:</p> <ol style="list-style-type: none"> <li>Where a Club is an unincorporated association, the Club chairman and secretary; or</li> <li>Where a Club is an incorporated entity, two directors of the Club.</li> </ol> <p>Any alteration of the chairman and /or secretary of the Club on the above agreement must be notified to the Nottinghamshire County Football Association(s) to which the Club is affiliated and to the Secretary.</p> <p>Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>
<b>11. CONTINUATION OF MEMBERSHIP, WITHDRAWAL OF A CLUB</b>	
11.A	Any Club intending, or having a provisional intention, to withdraw a Team from the Competition must do so at least 7 days before the AGM. This does not apply to a Club moving in accordance with Rule 22(B). Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
11.B	The Management Committee shall have the discretion to deal with a Team being unable to start or complete its fixtures for a Playing Season, including but not limited to, issuing a fine in accordance with the Fines Tariff.
11.C	Notwithstanding the powers of the Management Committee pursuant to Rule 6(I), in the event of a Club failing to discharge all its financial obligations to the Competition in excess of £50, the Management Committee shall be empowered to refer the debt under The FA Football Debt Recovery provisions.
<b>12. EXCLUSION OF CLUBS OR TEAM. MISCONDUCT OF CLUBS, OFFICERS, PLAYERS, MANAGEMENT COMMITTEE</b>	
12.A	At the AGM or SGM called for the purpose in accordance with the provisions of Rule 9, notice of motion having been duly circulated on the agenda by direction of the Management Committee, the accredited delegates present shall have the power to: (i) remove a member of the Management Committee from office, (ii) exclude any Club or Team from membership, both of which must be supported by more than two-thirds (2/3) of those present and voting. Voting on this point shall be conducted by ballot. A member of the Management Committee or Club which is the subject of the vote being taken shall be excluded from voting.
12.B	At the AGM, or at a SGM called for the purpose in accordance with the provisions of Rule 9, the accredited delegates present shall have the power to exclude from further participation in the Competition any Club or Team whose conduct has, in their opinion, been undesirable, which must be supported by more than two-thirds (2/3) of those present and voting. Voting on this point shall be conducted by ballot. A Club whose conduct is the subject of the vote being taken shall be excluded from voting.

12.C	Any Officer or member of a Club proved guilty of either a breach of Rule, other than field offences, or of inducing or attempting to induce a Player or Players of another Club in the Competition to join them shall be liable to such penalty as a General Meeting or Management Committee may decide, and their Club shall also be liable to expulsion in accordance with the provisions of clauses (A) and/or (B) of this Rule.
<b>13. TROPHY</b>	
13.A	<p>The following agreement shall be signed on behalf of the winners of the cup or trophy:-</p> <p>“We A [name]and B [name], the Chairman and Secretary of [ ] FC(Limited), members of and representing the Club, having been declared winners of [ ] cup or trophy, and it having been delivered to us by the Competition, do hereby on behalf of the Club jointly and severally agree to return the cup or trophy to the Competition Secretary on or before [ ]. 13.B	At the close of each Competition awards may/shall be made to the winners and runners-up if the funds of the Competition permit.
<b>14. ALTERATION TO RULES</b>	
14	<p>Alterations, for which consent has been given by the Sanctioning Authority, shall be made to these Rules only at the AGM or at a SGM specially convened for the purpose called in accordance with Rule 9. Any alteration made during the Playing Season to these Rules shall not take effect until the following Playing Season, except in exceptional circumstances where approved by Sanctioning Authority and The FA.</p> <p>Notice of proposed alterations to be considered at the AGM shall be submitted to the Secretary by 1<sup>st</sup> February in each year. The proposals, together with any proposals by the Management Committee, shall be circulated to the Clubs by 30<sup>th</sup> April and any amendments thereto shall be submitted to the Secretary by 7<sup>th</sup> May The proposals and proposed amendments thereto shall be circulated to Clubs with the notice of the AGM. A proposal to change a Rule shall be carried if a majority of those present, entitled to vote and voting are in favour.</p> <p>A copy of the proposed alterations to Rules to be considered at the AGM or SGM shall be submitted to the Sanctioning Authority or The FA (as applicable) at least 28 days prior to the date of the meeting.</p>
<b>15. FINANCE</b>	
15.A	The Management Committee shall determine with which bank or other financial institution the funds of the Competition will be lodged.
15.B	All expenditure in excess of £100 shall be approved by the Management Committee.
15.C	The financial year of the Competition will end on 15 <sup>th</sup> may
15.D	The books, or a certified balance sheet, of a Competition shall be prepared and shall be audited/verified annually by a suitably qualified person(s) who shall be appointed at the AGM.
<b>16. INSURANCE</b>	
16.A	All Clubs must have valid public liability insurance cover of at least ten million pounds (£10,000,000) at all times.
16.B	<p>All Clubs must have valid personal accident cover for all Players registered with them from time to time. The Players’ personal accident insurance cover must be in place prior to the Club taking part in any Competition Match and shall be at least equal to the minimum recommended cover determined from time to time by the Sanctioning Authority. In instances where The FA is the Sanctioning Authority, the minimum recommended cover will be the cover required by the Affiliated Association to which a Club affiliates.</p> <p>Failure to comply with Rule 16(A) or 16(B) will result in a fine in accordance with the Fines Tariff.</p>
<b>17. DISSOLUTION</b>	
17.A	Dissolution of the Competition shall be by resolution approved at a SGM by a majority of three quarters (3/4) of the members present and shall take effect from the date of the relevant SGM.
17.B	In the event of the dissolution of the Competition, the members of the Management Committee are responsible for the winding up of the assets and liabilities of the Competition.
17.C	<p>The Management Committee shall deal with any surplus assets as follows:</p> <ol style="list-style-type: none"> <li>Any surplus assets, save for a trophy or any other presentation, remaining after the discharge of the debts and liabilities of the Competition shall be transferred only to another Competition or Affiliated Association or The Football Association Benevolent Fund or to such other charitable or benevolent object in the locality of the Competition as determined by resolution at or before the time of winding up, and approved in writing by the Sanctioning Authority.</li> <li>If a Competition is discontinued for any reason a trophy or any other presentation shall be returned to the donor if the conditions attached to it so provide or, if not, dealt with as the Sanctioning Authority may decide.</li> </ol>
<b>MATCH RELATED RULES</b>	
<b>18. QUALIFICATION OF PLAYERS</b>

Contract Players are not permitted in this Competition with the exception of those Players who are registered under contract with the same Club who have a Team operating at Steps 1 to 6 of the National League System, or Tiers 1-4 of the Women's Pyramid System.</p> <p>It is the responsibility of each Club to ensure that any Player registered to the Club has, where necessary, the required International Transfer Certificate. Clearance is required for any Player aged 10 and over crossing borders including Wales, Scotland and Ireland.</p> <p>2. A Player registered with a Premier League or EFL Academy under the Elite Player Performance Plan contained within Youth Development Rules will not be permitted to play in this Competition, except for those in the under 11 age-group and below where consent has been given by the relevant Premier League or EFL (such consent can be withdrawn at any time). Trial players are not considered to be registered with a Premier League or EFL Academy for these purposes and therefore the prohibition on playing in the Competition does not apply to them. The relevant Premier League/EFL Academy remains responsible for managing the frequency of the player's playing time. Details of the Youth Development Rules are published on The FA website. 18.C	<p>A child who has not attained the age of 6 shall not play, and shall not be permitted or encouraged to play, in a match of any kind.</p> <p>The relevant age for each Player is determined by their age as at midnight on 31 August of the relevant Playing Season i.e. children who are aged 6 as at midnight on 31 August in a Playing Season (together with those who attain the age of 6 during the Playing Season) will be classed as Under 7 Players for that Playing Season. Overhead netting is allowed for 5v5 and 7v7 mini soccer if the overhead netting height is at a minimum of 6m. No overhead netting is allowed for 9v9 and 11v11 affiliated matches.

Overhead wires used to support pitch divider netting are ideally removed for affiliated matches but if they cannot be removed then discretion is given to the match official to restart the match in accordance of the laws of the game.

All Competition Matches shall have a duration as set out below unless a shorter time is mutually arranged by the two Clubs in consultation with the referee prior to the commencement of the Competition Match, and in any event shall be of equal halves.

Competition Matches should be played in accordance with the Laws appropriate to the relevant age group, as laid down by The FA, as detailed below.

Should either or both of the leading Teams in any of the divisions have a Team in the next higher division, promotion shall fall, at the discretion of the General Meeting, to the next highest Team or Teams in the division concerned.</p> <p>5. Should either or both of the relegated Teams in any of the divisions have a Team in the next lower division, relegation shall fall, at the discretion of the General Meeting, to the next lowest Team or Teams in the division concerned.</p>
22.C	Rule Not applicable to KYL - In addition to the Team(s) automatically promoted under Rule 22(B), a maximum of one further Team shall be promoted by virtue of being the winner of a play-off match or series of matches (the "Play-Offs). The eligibility criteria and format of the Play-Offs are as follows [ ].
22.D	In the event of a Team withdrawing from the Competition before completing 75% of its fixtures for the Playing Season all points obtained by or recorded against such defaulting Team shall be expunged from the Competition table. For the purposes of this Rule 22 (D) a completed fixture shall include any Competition Match(es) which has been awarded by the Management Committee.
<b>23. MATCH OFFICIALS</b>	
23.A	Registered referees (and assistant referees where approved by The FA or County FA) for all Competition Matches shall be appointed in a manner approved by the Management Committee and by the Sanctioning Authority.
23.B	In cases where there are no officially appointed Match Officials in attendance, the Clubs shall agree upon a referee. An individual thus agreed upon shall, for that Competition Match, have the full powers, status and authority of a registered referee. Individuals under the age of 16 must not participate either as a referee or assistant referee in any open age competition and individuals under the age of 14 must not participate either as a referee or assistant referee in any Competition Match. Referees between the ages of 14 and 16 are only eligible to officiate in competitions where the Players' age band is at least one year younger than the age of the referee, for example a 15 year old referee may only officiate in competitions where the age banding is 14 or younger.
23.C	Where assistant referees are not appointed each Team shall provide a Club assistant referee. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff) being imposed on the defaulting Club.
23.D	The appointed referee shall have power to decide as to the fitness of the Ground in all Competition Matches and that decision shall be final, subject to the determination of the Local Authority or the owners of a Ground, which must be accepted.
23.E	<p>Subject to any limits/provisions laid down by the Sanctioning Authority, Match Officials appointed under this Rule shall be paid a match fee in accordance with the Fees Tariff and inclusive of travel expenses.</p> <p>Match Officials will be paid their fees and/or expenses by the home Club before/immediately after the Competition Match, unless otherwise ordered by the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.</p>
23.F	In the event of a Competition Match not being played because of circumstances over which the Clubs have no control, the Match Officials, if present, shall be entitled to expenses only. Where a Competition Match is not played owing to one Club being in default, that Club shall be ordered to pay the Match Officials, if they attend the Ground, their full fee and expenses. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
23.G	A referee not keeping their engagement, and failing to give a satisfactory explanation as to their non-appearance, may be reported to the Affiliated Association with which they are registered.
23.H	Each Club shall, in a manner prescribed from time to time by The FA, award marks to the referee for each Competition Match and the name of the referee and the marks awarded shall be submitted to the Competition on the prescribed form provided. Clubs failing to comply with this Rule shall be liable to be fined (in accordance with the Fines Tariff) or dealt with as the Management Committee shall determine.
23.I	The Competition shall keep a record of the markings and, on the form provided by the prescribed date each Season, shall submit a summary to The FA/County FA.
23.J	<i>The referee shall submit a report form, supplied by the Competition, giving the result of the Competition Match, the number of Players in each Team and the time of kick-off to the (Registration) Secretary within two days of the Competition Match.</i>
23.K	<i>Match Officials shall be supplied, each season, with a copy of the Competition Rules free of charge.</i>
23.L	<i>Match Officials shall have undertaken a RESPECT briefing offered by The FA/County FA or the Competition.</i>
